Thank you for your email. As you were informed in Mid-December by my colleague Dalton Barrientos, Sida is required to consult with the Swedish Ministry of Foreign Affairs before releasing these documents. The documents are still with the Ministry and hence

we are awaiting their consultation. Before we have received this consultation, a decision cannot be made by us and hence there is not yet a decision to appeal.

As soon as we get the assessment from the Ministry we will release the documents. Should information in the documents be deemed secret, this information will be redacted before disclosure. Should you then wish to receive a decision regarding the disclosure you can request for this and we will provide you with the decision, which can also be appealed. This is how our process for releasing public information is conducted.
